So, what's an insurer to do if they need a faster way to review and process incoming medical documents?



Fast-Track Applications With Machine Learning

The beauty of cognitive capture is that it learns. By integrating predictive analytics, it has the power to emulate what the human brain does: recognize patterns. A machine learning algorithm emulates that to help underwriters make decisions faster.

More specifically, a system can then fast-track decisions. If the system finds a positive diagnosis for cancer, heart disease or diabetes, it flags the applicant as high-risk, so the underwriter can immediately decline the policy application.

Conversely, it can facilitate quick approvals for the underwriter. If it does not find any critical conditions related to cancer, heart disease or diabetes, then it flags the applicant as low-risk.

This prevents an underwriter from devoting precious time towards applications that are obvious approvals or denials. Instead, they can focus on complex cases. Additionally, the ability to fast-track applications creates more throughput with the same number of underwriters, enabling the organization to expand and grow into new markets.

As more and more applications go through the system, its accuracy at identifying low-risk and high-risk applicants improves.
