### THE CHALLENGE

EMPLOYERS Insurance Group faced a series of strategic objectives that demanded attention. These objectives included addressing technical debt, improving processing efficiencies, and elevating customer service metrics. To tackle these challenges, they embarked on an intensive eight-month vendor evaluation journey, which led them to select Pyramid Solutions as their primary vendor, with IBM technology serving as their preferred automation platform. Their criteria for selection encompassed two key elements:

#### A Strategic Partner in Innovation:

• Their chosen vendor needed to possess industry expertise and a demonstrated track record of effectively implementing modern technology to streamline business processes.

#### A Robust and Agile Technology Platform:

- The selected technology platform had to offer flexibility to address a variety of business automation scenarios.
- It was imperative that the technology platform demonstrated a low Total Cost of Ownership (TCO) and an open architecture that facilitated seamless integration with existing systems.

### THE SOLUTION

Revamp Claims Processing: EMPLOYERS embarked on a multi-year transformation program aimed at replacing their in-house claims processing and policy management systems. The initial focus was on the claims processing business, and here is how the transformation unfolded:

- The legacy claims processing system was replaced by three new systems: a new Claims processing system of record, a Customer Correspondence Management system for generating outbound customer correspondence, and IBM's FileNet P8 as the repository.
- A cloud-first strategy was adopted for all new technology, encompassing Identity and Access Management, API Gateways, and dedicated VPN tunnels within a hybrid-cloud environment.
- Data and content were successfully migrated from an on-premises custom repository to a more agile and scalable cloud-based repository.
- Document ingestion was streamlined, covering network drives, scanners, and third-party service providers.
- The packaging and delivery of documents to external entities, such as state regulators and legal entities, was automated.
- A seamless and integrated user experience was ensured across the three newly implemented systems.
- Operational data was efficiently delivered to their data lake for in-depth analytics and reporting.

Upgrade the Policy Management System: Building upon the foundation laid by the Claims project, EMPLOYERS initiated a similar transformation for their Policy Management System in the second project:

- The legacy policy management system was replaced with two new systems: a new Policy Management system of record, IBM's FileNet as the repository as well as versatile workflow engine.
- Data and content were migrated from an on-premises ImageRight repository to the cloudbased repository.
- ImageRight Document Routing workflows were replaced with the more flexible and feature-rich FileNet workflows.
